This AD is issued in accordance with EC 1702/2003, Part 21A.3B. In accordance with EC 2042/2003 Annex I, Part M.A.301, the continuing airworthiness of an aircraft shall be ensured by accomplishing any applicable ADs. Consequently, no person may operate an aircraft to which an AD applies, except in accordance with the requirements of that AD, unless otherwise specified by the Agency [EC 2042/2003 Annex I, Part M.A.303] or agreed with the Authority of the State of Registry [EC 216/2008, Article 14(4) exemption].

# Required Action(s) and Compliance Time(s):

Required as indicated, unless accomplished previously:

(1) Within the time indicated in Table 1 of this AD, inspect the attachment brackets of the emergency flotation gear in accordance with the instructions of paragraph 3 of Eurocopter AS350 ASB 05.00.63 or AS355 ASB 05.00.58, as applicable to helicopter type.

- (2) After the initial inspection as required by paragraph (1) of this AD, at intervals not exceeding 13 months, repeat the inspection of the attachment brackets of the emergency flotation gear in accordance with the instructions of paragraph 3 (except paragraph 3.B.2.a.) of Eurocopter AS350 ASB 05.00.63 or AS355 ASB 05.00.58, as applicable to helicopter type.
- (3) If, during any inspection as required by paragraph (1) or paragraph (2) of this AD, cracks are found, before next flight, replace the affected bracket in accordance with the instructions of paragraph 3 of Eurocopter AS350 ASB 05.00.63 or AS355 ASB 05.00.58, as applicable to helicopter type.
- (4) From the effective date of this AD, do not install emergency flotation gear attachment brackets with Part Number (P/N) 158172, P/N 158173, P/N 158288, or P/N 158289 which have logged flight hours on any helicopter, unless the attachment bracket has passed the inspection in accordance with the instructions of paragraph 3.B.2. of Eurocopter AS350 ASB 05.00.63 or AS355 ASB 05.00.58, as applicable to helicopter type.
- (5) Installation of a new bracket with (P/N) 158172, P/N 158173, P/N 158288, or P/N 158289, does not constitute terminating action for the repetitive inspection required in paragraph (2) of this AD.
